(ix) To take up relief and rehabilitation missions during natural disasters calamities and environmental hazards and accidents.

(x) To give, provide, and/or render help and assistance to and/or in any shape or form to the poor deserving and needy persons and to receive donations, subscriptions and contributions from the public, Private agencies/persons and to apply for registration under 80G of Income Tax Act-1961.

(xi) To build, erect and construct and to aid and assist in he construction of poor homes, water sheds and community centers for use of the general public.

(xii) To construct and run a community centre and to let it out to deserving people for a nominal rent which may be decided upon by the trustees, but without any profit motive.

(xiii) To give all necessary assistance for the disabled persons, deaf, dumb, mute, etc by way of financial assistance or any other assistance in kind by purchasing and supplying them necessary equipments, etc or any other type of assistance required by them.

(xiv) To grant scholarship, prizes awards and to otherwise and assist deserving students in promoting their education, academic and other attainments.

(xv) To start, maintain and assist any relief measures in the event of any natural calamities such as flood, fire, drought, cyclone, earthquake, accident etc. or any type of welfare activities.

(xvii) To run maintain and start institutions/destitute/old age homes for the aged and poor widows, lunatics and destitute, needy persons.

(xviii) To provide help and assistance in cash or kind to poor, disabled and infirm persons.

(xxiv) To provide assistance and implement any scheme for lively hood and upliftment of poor and down trodden people of the country.

(xxv) To organize medical and health check up centre, blood donation and eye donation camps in the slum and any part of the country.

(xxvi) To set up and render free legal advice and legal aid camps to needy people.

(xxvii) To set up, run, maintain and assist hospitals, charitable dispensaries, maternity homes, child welfare centre, medical colleges, Nursing training colleges, laboratory technician, etc. to set up Dharmasalas etc.

(xxviii) To create memorial fund or other National and charitable funds promoted by the central or state govt. or others.

5. BOARD OF THE TRUSTEES:

The management and control of the Trust and trust properties shall vest with the Board of Trustees. The Board of Trustees shall comprise of the following trustees including the Settlor, Managing Trustee and Other Executive Trustees.

6. QUALIFICATION OF THE TRUSTEES :

No person being an un discharged insolvent; or convicted of an offence involving moral turpitude; or of unsound mind; or a minor; or possessed bad social reputation to the best knowledge.

7. DISQUALIFICATION OF TRUSTEES:

A Trustee shall be liable for disqualification during the continuance in the office of the Trust in any of the following events:

- If he/she found Committing any breach of trust.
- If he/she found Working detrimental to interests, benefits, dignity reputation and good will of the trust.
- If he/she has been convicted of any offence involving moral turpitude by any court of law or convincingly to the best satisfaction of the Board of Trustee :
- If he/she becomes bankrupt, un discharged insolvent;
- If he/she becomes permanent insane.
- If he/she remains absent for long term of 3 years in the meeting of the Trust Board.

8. FINANCIAL POWERS AND FUNCTIONS:

- a) To borrow if needed against the security of the assets of the trust by way of bank overdrafts, loan or otherwise, as may be necessary, for the benefit of the trust from any financial agency and for more effectively carrying out the objects of the trust. And to borrow, if needed by way of executing bonds or otherwise, from the trustees of these presents as may be necessary, for the benefit of the trust and for effectively performing the objects of the trust.
- b) To spend any portion of the corpus or the income of

the trust fund for purchasing any land and/or constructing any building or buildings for and in the name of the trust for the purpose of carrying out, promoting and/or executing any or all of the objects of the trust.

c) To accept, receive and/or cause to receive any donation or contribution, grants in cash or in kind or in any from whatsoever from any person, firm, Govt., Company, Corporation, Society, Associations, Institution or trust for the furtherance of the objects of the trust or for any one or more of them upon such terms and conditions as the Board of Trustees may in his absolute discretion think fit and which are not inconsistent with the objects of the trust. The Board of trustees may also take over the management of any other charitable or public institutions on such terms as think fit and may manage, administer, supervise such institutions.

9. MEETING OF THE TRUST BOARD:

i. The trustees of the Board shall meet at least fourth time every year. In case of emergent contingencies, circulatory or extraordinary meetings can be organized.

ii. All the resolutions adopted in the meetings of the trust board shall be recorded in the book of proceedings.

iii. All such meetings of the Trustee Board shall be convened by Managing Trustee in absence of Chairman as and when required.

iv. All the meetings of the Trust Board shall transact any business upon attendance of majority the Trustees to form quorum. All decision will resolve upon the managing trustee.

10 POWER AND FUNCTION OF THE MANAGING TRUSTEE CUM SETTLOR

(a) The Managing Trustee is the Chief Executive of the Trust and the Trust Board.

(b) To conduct all correspondences of the Trust in conformity and shall be in charge of all its records, documents and properties and shall preserve them/ those in order and maintain the proper order and conditions all office furniture and other properties of the Trust.

(c) To collect or cause to be collected all subscriptions,

fees, donations, receipts, grants and get in with due diligence all other moneys due and payable to the Trust, make over all collections as and when received or realized and requisition for such money as may from time to time be needed for meeting necessary expenses as sanctioned by the Trust.

(d) To make all payments of the Trust after necessary bills and vouchers have been fully checked by him and passed for payment. To deposit all moneys as and received from any source in to the accounts of the Trust with the Banks.

(e) To cause the accounts of the Trust to be duly audited by the appointed Chartered Accountant or Approved Auditors.

(f) To enter into agreement-Memorandum of Understandings, deeds and contracts in consultation with the Trust Board.

(g) To appoint, remove, terminate, and suspend the paid and honorary employees and trustees, volunteers, workmen, and staffs of the Trust.

(h) Upon approval of the Trust Board, to receive any grants, financial assistance, projects, funds, loans, etc. in shape of cash, documents and instruments or in kind from any persons, agency, company, organization, Govt. Department, Foreign agencies or bodies, And to apply, use, utilize the same in the manner as required.

(i) To keep all the titles, deeds of properties or liquid cash or bank receipts other deposits, receipts and other important and valuable documents or articles of value in safe custody.

(j) To delegate any of his power to any trustee of the trust for any specific duty/purpose and shall withdraw such delegation at his will at any time without assigning any reason or notice.

(k) To supervise the smooth maintenance and operation of the trust properties and activities of the Trust.

(l) Shall have all the powers and privileges generally vested in him and To do all such acts and exercise all powers, be it administrative, financial, managerial, supervisory powers incidental to the working of the aforesaid duties and to the best interest, benefit and welfare of the trust.

(m) .To apply for opening of Institutions under such capacities as required.

11.POWER AND FUNCTION OF THE OTHER TRUSTEES:

(i) The Board of Trustees may authorize any trustee(s) to do all or any functions as here-under:

- a. To convene all meetings and shall cause minutes of all proceedings and resolutions of all such meetings to be correctly recorded in a book specially provided for the purpose and such minutes shall upon questions put and votes taken and when signed by him shall be conclusive evidence of the correctness of the entry. He is to carry out and execute the decision of the Trust Board.
- b. To Conduct all correspondence of the Trust in conformity with the decision of the Managing Trustee and shall be in charge of all its records, documents and properties and shall preserve them/ those in order.
- c. To Keep up to date registers of the Trust.
- d. To Sign and issue all receipts on behalf of and for the trust.
- e. To have custody of and maintain the proper order and conditions all office furniture and other properties of the Trust.
- f. To prepare every year the annual report on the working of the Trust after getting that duly approved by the Trust Board.
- g. To Place before the Trust Board, half yearly statement of accounts, reports of the Committees or Sub Committees, if any and implement the decision of the Trust.
- h. To Prepare and place the budget for the year before the Board of Trust.

(ii) In addition to the duties assigned to them by the Board of Trustees from time to time, the trustees will generally assist the Chairman and Managing Trustee in the management and administration of the Trust Properties and activities. In such case, the concerned trustee shall do all the acts in all

12. QUORUM:

Trustees including Settlor at a meeting shall form a quorum for any meeting of the Trust Board. Notice of the meeting of the Trustees and all communications may be sent to the trustees at their addresses for the time being in the records of the trust.

13. FUNDS MANAGEMENT:

The Board of trustees through the Managing Trustee of the Trust may from time to time open and maintain in the name of the trust and banking accounts with such scheduled banks or nationalized banks, or co-operative banks, private banks or other approved banks as may from time to time be determined by the Board of Trust and shall forthwith pay or cause to be paid the rents, incomes, earning, savings, dividends and other receipts like grants, donations, certificates, etc and all other moneys forming part of the trust fund to the credit of any such account or accounts, all such accounts are to be operated by Settler- cum-Trustee of the Trust , Treasurer-cum-Trustee jointly.

14. ACCOUNTS AND AUDIT:

The Managing Trustee in consultancy with the Trust Board shall maintain regular accounts of the trust fund and systematic programmes and project assistance and shall get the same duly audited by a firm of chartered accountants. The accounts and audit report shall be maintained and published annually along with the annual report of the Trust.

15. RESIDUARY POWER:

Any matter not provided for in these present shall be dealt with by the absolute discretion of the trustees

16. MANAGEMENT OF TRUST:

a) The management, control of the property, accounts and affairs of the trust aforesaid shall be vested in the Trustees in general and founder in particular.

b) That trustees shall meet at least once in every six months at such places and times as they may decide from time to time for efficient man agreement of the trust, to

consider the income and expenditure and for disposing of all such other matters as may arise in such meetings.

c) At all meetings of the trustees, two members including the chairman will form the quorum.

d) All proceedings of the meeting of the trustees shall be recorded in a Minute Book kept for the purpose.

e) Trustees who fail to attend three consecutive meeting without prior intimation or information shall cease to be trustees unless otherwise majority of the other trustees accord him exception on.

f) In case of different of opinion among the trustee on a particular matter, the opinion of majority of the trustees shall prevail. If there is no opinion of clear majority, the Chairman shall cast his second vote. If still there was a balance in the opinion to which Chairman Supports would prevail.

17. POWER TO PURCHASE, HIRE OR TAKE ON LEASE:

The Trust of Trustee shall be entitled to purchase or hire or to take on lease a property or properties for the purpose of carrying out the objects of the trust hereby created.

18. EFFECT OF APPOINTMENT OF NEW TRUSTEES:

Upon every such appointment made in pursuance of the last foregoing clauses thereof, the newly appointed trustees shall have powers and authorities of a Trustee under THESE PRESENTS.

19. POWER TO BORROW:

The Trustees may from time to time at their discretion for the furtherance and carrying out the objects of the Trust of THESE PRESENTS, borrow such sum as may be determined by the Trust of Trustees from time to time in form dispositions of the properties movable of immovable forming part of the Trust Fund or any part thereof and enter into such agreements, assurance and thing on relation thereto as the Trustees may deem proper for giving security for such loan and interest.

20.FINANCIAL YEAR:

The financial year of the trust shall end on 31st March, every year provided that the Board of Trustees shall be at liberty to change the same from time to time if they so deem it fit and proper.. The Trust shall be audited for every financial year by the authorised Chartered accountant. The first financial year of the Trust shall close on 31st March, 2025.

21.INVESTMENT OF THE TRUST FUND:

All money forming part of the Trust fund and requiring investment shall be invest in any of the securities authorized by the law of investment of the Trust Funds which are permissible under section 11(5) of the income-tax Act 1961 or shall at their discretion sell and / or realize the same or any part thereof.

22.AMENDMENTS:

The Board of trustees may make any amendments, add to the rules, he may consider necessary for the better management of or administration of the Trust and Trust properties and Trust objective. But in no case, the trustee can make amendment to the main features, fundamental principles of the aims and objectives of the Trust under these presents.

23.SECRECY:

The trustees shall maintain the confidentiality of the trust, Trust properties and its affairs.

24.SEAL:

There shall be a common seal of the trust, which shall be affixed at the direction of the Trustees. The composition of the said seal may be altered from time to time upon the discretion of the Trustees.

25.INDEMNITY TO THE TRUSTEES:

The Trustees shall not be answerable or accountable to acts, receipts, neglects and defaults done by any bankers, or any other person with whose or into whose hands the trust money or securities may be deposited or come in accordance

26. POWER TO AMALGAMATE OTHER TRUSTS, ETC.:

30.UTILIZATION OF TRUST FUNDS:

All activities financed from the trust fund shall be utilized in accordance with the ideals and objectives as stated herein and no discrimination shall be permitted therein on grounds of religion, caste, creed or sex provided that any donation, grants, assistance, etc. earmarked and accepted for any specific purpose falling within the objects mentioned in these presents shall be for such specific purpose.

31.EXCHANGE OF IDEAS AND EXPERIENCES:

The trust and trustees may act as a channel for inter change of ideas and experiences created through its innovations by training workshops, seminars, conferences, meetings, symposia, discussions, demonstrations, exhibitions and publication and etc.

32.DISSOLUTION:

In the event of any unforeseen circumstances, if the trust so created need to be dissolved or revoked, it can be done so only upon decision of the trustees. In such case, the properties of the trust and all assets of the trust after full



settlement of all the dues and liabilities shall be donated to any other charitable organization having legal entity and aims and objects similar to those of the trust or to the State/Central government after squaring of or liquidating all the liabilities of the trust.

33.ACQUISITION OF TRUST PROPERTY BY GOVERNMENT:

In case of acquisition of the trust properties or any portion thereof, the trustees shall invest the compensation money either in purchase of some other income fetching property(s) or purchase some securities to be held by him or them on the same terms as to trust hereunder created and that the trustees so appointed will have the same powers and rights as if he or they was or were originally appointed by the settler under these presents.

34.LEGAL PROCEEDINGS BY AND AGAINST THE TRUST:

The trust shall sue or to be sued in the name of the Trust. The Court at BHUBANESWAR, Orissa, India only shall have the jurisdiction to try or entertain any judicial proceedings by or against the trust.

35.No part of the income or property of the trust shall be distributed to any of the trustees or their families.

33. Save as otherwise provided in this deed of trust, the provisions of Indian trust act 1882 as amended will apply in respect of the trust.

36.The Trust shall file the income tax return for every year as per the rule of Income Tax Department, Govt. of India.
